

FINAL CONFERENCE AGENDA

TWING aims to explore the impact of COVID-19 crisis on telework, working conditions and industrial relations with the overarching objective of supporting social partners in the promotion of decent and productive telework in the post-COVID-19 scenario.

For this purpose, the project analyses four sectors which face different constraints in relation to telework and six countries that differ on the prevalence and ways of regulating telework, and are representative of different industrial relations regimes.

This sectoral and country selection enables comparative analysis and policy recommendations at the European level.

The final conference assembles all project partners and participants. In dialogue with key stakeholders from academics and social partners, the final conference shall give the floor to share, disseminate and critically assess TWING findings. The conference will provide simultaneous interpretation into English and Spanish.
